PART 1 - EXTRACT OF INDENTURE DATED 1.8.1873

When the Manor of Chardstock was sold by the Ecclesiastical Commissioners to Baron Henley by Indenture dated 1.8.1873, certain parcels of ground were retained by the Church and were not included in the sale:

- 1) "One plot of ground called the Vicarage Orchard containing one acre of ground".
- 2) "All that piece or parcel of garden ground containing by admeasurement thirty one perches situate lying and being in the Parish of Chardstock formerly part of Court Farm Orchard".
- 3) "All that piece or parcel of land or ground also lying and being in the said Parish called Parkes containing by admeasurement three acres and five perches and numbered 412 on the Tithe Commutation Plan".
- 4) "All that other piece or parcel of land or ground also situate lying and being in the said Parish also called Park containing by admeasurement seven acres two roods and twenty one perches numbered 418 on the said plan".
- 5) "All that piece or parcel of land or ground being part of the South Common also situate lying and being in the said Parish at the East end of All Saints Church or Chapel containing by admeasurement one acre, as the same is fenced off from the said Common".

For these lands the Church paid a yearly rent of £48 5s 8d, this being "the amount of the yearly Land Tax formerly charged on the premises".

PART 2 - INDENTURE DATED 1.8.1873 INCLUDING SCHEDULE OF MORTGAGES AND ARRANGEMENTS FOR THE GRANTING OF LEASES ON HOLDINGS PREVIOUSLY COVERED BY COPYHOLD AGREEMENTS

The Estate Trustees of the Legal and General Life Assurance Society agreed to repay the Corporation (The Governors of the Charity for the Relief of Poor Widows and Children of Clergymen) the sum of £10,000. As interest had been paid annually by Baron Henley on the £52,000 mortgage, the debt was reduced to £42,000.

The following extract from this Indenture is an exact copy as it explains the legal mechanism whereby Baron Henley could grant leases on holdings previously covered by copyhold agreements - "And the said Baron Henley and the said Nathaniel Tertius Lawrence covenanted with the Corporation that the said Nathaniel Tertius Lawrence would stand possessed of certain Copyhold tenements parcel of the said Manor to which he had been admitted and which were held by him as Trustee for the said Baron Henley to the intent that the same might thenceforth be held as part of the demesne lands of the Manor fixed and discharged from the Copyhold tenure thereof and it was thereby agreed that until the said tenements should be surrendered the said Nathaniel Tertius Lawrence his heirs and assigns should hold the same in trust for the Corporation their successors and assigns subject to the proviso for redemption thereinafter contained and by the said Indenture a power was reserved for the said Baron Henley to grant leases for any term not exceeding twenty one years in possession of the best rent and to grant certain Licences to Copyholders and also to make certain customary grants for lives".

PART 3 - INDENTURE DATED 18.4.1891 INCLUDING COPYHOLD AGREEMENTS EXPIRING BETWEEN 1873 AND 1891

Between Baron Henley and the Estate Trustees of the Legal and General Life Assurance Society for a Mortgage of £13,500 with interest secured against the Manor of Chardstock and No. 19 Whitehall Place. Additional information extracted from this Indenture is shown below.

At a Court Baron on 22.10.1873 Nathaniel Tertius Lawrence surrendered to Baron Henley all the copyholds held by him in Trust at the time of the estate sale.

Between the Indentures dated 1.8.1873 and 18.4.1891 twenty Copyhold agreements (numbered 13, 17, 19, 20, 32, 73, 95, 109, 110, 111, 112, 125, 129, 135, 136, 139, 140, 142, 144 and 149 - a total of 264A 3R 27P) "have fallen into hand and are now held as part of the demesne lands of the Manor and the same demesne lands of the Manor now contain 2620A 1R 36P or thereabouts".

By comparing the information in this document with that held in an Abstract of Title dated 1915, it is possible to produce the schedule below giving details of the twenty Copyhold agreements which expired between 1.8.1873 and 18.4.1891.

Indenture dated 18.4.1891 between Baron Henley and the Estate Trustees of the Legal and General Life Assurance Society for a Mortgage of £13,500 with interest secured against the Manor of Chardstock and No. 19 Whitehall Place. This Indenture included a schedule of the 66 Copyholds agreements, totalling 1002A 3R 14P, still current at that date.
